I. Call to Order

Chairman McDonald called the regular meeting of the Denair Community Services District's Board of Director's to order at 6:03 p.m.

III. Approval of the Minutes

The Board unanimously approved the minutes from the Regular Meeting held on July 19, 2022, as prepared by Secretary Gomes. (Edwards & Bradley)

IV. Old Business

A. The Board unanimously approved the Report of Funds as for August 16, 2022, and September 20, 2022, as prepared by Secretary Gomes. (Kuffel & Bradley)

B. Manager's Report

WTS/GSA/JPA:

A Board meeting was held On August 11, 2022. Department of Water Resources (DWR) are still reviewing the GSP submissions for recommendations and/or approval. Out of 20 submissions, only 8 were passed through DWR. We are hopeful that our GSP passes without any or

few recommendations. The Board also passed two Master Service Agreements (MSA) with Todd Groundwater and Woodard & Curran. Once the GSP is approved they will assist throughout the implementation process.

WATER LEVELS:

August 2022: 116' August 2021: 114'

September 2022: 115.1' September 2021: 109.6'

CONSERVATION:

July 2022: 27.58% August 2022: 23.41%

To date, we have conserved/saved 75 million gallons of water.

DEVELOPERS:

Torre Reich (Story Road) – Public hearing held to rezone the lots to utilize 50% of the pad for larger single-story homes.

Lazares Dev. / Monte Vista Collection (Trevor Smith) – Our District Engineer is currently working with the developers engineer on the well design and will report when complete for review and approval.

Dunkley (Zeering & Riopel) – Nothing to report.

Sequeira / Heans Martin Project (Kersey Rd. Project) – Nothing to report.

Isaaco Estates / Sam David (Dean Wilson) - Nothing to report.

NEW SERVICE TRUCK:

Currently at Stiles having the bed installed.

SURFACE WATER TREATMENT PLAN:

Tank on Quincy is still under construction. 18" valve along with a turn out has been installed and will be available to the District if needed in the future.

DAMAGE/VANDELISM:

Vehicle doing "burn-outs / doughnuts" in the parking lot.

COMMUNITY CENTER:

New floors are scheduled to be installed November 2022.

WATER LINE REPLACEMENT:

We will be replacing a water line on Stacey Court because of a recent leak on Thursday September 22, 2022. Customers will have water service interrupted from 8:30-3:30.

BACKHOE:

The new backhoe was delivered about a week ago. We will begin using it to install new fire hydrants and valves in the most needed areas soon.

V. New Business

A. Rescind Resolution 2022-002 that Authorized Manager Odom to Invest District Funds in the Local Agency Investment Fund (LAIF) and accept Resolution 2022-003 that Authorizes Manager Odom and a second District officer, Vice Chairman/Director Matthew Kuffel to Invest District Funds in the Local Agency Investment Fund (LAIF), as recommended by the LAIF representative. (2022-003)

On a motion made by Director Kuffel and seconded by Director Bradley, the Board unanimously approved to rescind Resolution 2022-002 and accepted Resolution 2022-003 in its place that Authorizes Manager Odom and a second District officer, Vice Chairman/Director Matthew Kuffel to Invest District Funds in the Local Agency Investment Fund (LAIF), as recommended by the LAIF representative.

B. Accept Resolution 2022-004 that Authorizes Manager Odom and a second District officer, Board Chairman Tommy "TJ" McDonald or Vice Chairman Matthew Kuffel to invest District funds into LPL Financial @ Bank of Stockton. It is the District's policy that two signatures are required for any transactions to occur. (2022-004)

On a motion made by Director Comfort and seconded by Director Kuffel, the Board unanimously accepted Resolution 2022-004 to Authorize Manager Odom and a second District officer, Board Chairman Tommy "TJ" McDonald or Vice Chairman Matthew Kuffel to invest District funds into LPL Financial @ Bank of Stockton. (2022-004)

C. Review options for the emergency repair of Well #7 and approve or deny the use of prior accumulated District funds for the repair of Well #7.

On a motion made by Director Edwards and seconded by Director Bradley, the Board unanimously approved the use of the District's Prior Accumulated Funds to repair Well #7.
