Average static level for all four wells is 105'. That is 8' lower than last year.

**Dunkley (Zeering & Riopel)** – The process to be annexed into the District through LAFCO has started. It will more than likely take almost up to a year before it is approved and included in the District. It is being proposed that this development will allow a single-family home, an accessory dwelling unit (ADU), and possibly a junior accessory dwelling unit on each lot. Each building will have it's own address and require fire sprinklers within the home or ADU. Citizens who oppose this type of project can contact Stanislaus County to voice concern regarding the project.

**Monte Vista Collection** and the **Dunkley** project will likely share the cost of constructing a new well that is need in the District. They will be given credits through each building permit (per the advice of the district engineer) to cover the cost of the well.

**Sequeira / Hanes Martin Project (Kersey Rd. Project)** – Developer's Agreement is ready for pick up.

**Isaaco Estates / Sam David (Dean Wilson)** - Developer's agreement has been signed and project ready to begin.

### **NEW SERVICE TRUCK:**

The new service truck is built. However, they key was stolen. Therefore, we are again waiting for a replacement.

### **DAMAGE/VANDELISM:**

We've had two incidents of cars doing donuts/burn-outs in the parking lot. If it continues, we may suggest installing parking curbs.

#### COMMUNTIY CENTER FLOOR REPLACEMENT:

Based on the information provided by the Denair Lion's Club, that they will contribute \$39,000 towards replacing the Community Center flooring with concrete, the Board will take action at the next meeting following recommendation from the District Auditor regarding the use of "Center" funds.
